The Releasors do hereby waive, release and discharge, and covenant not to sue, the ASUNAA DCAAC, and its officers, directors, trustees, employees, staff, volunteers, and supervisors and their successors and assigns (collectively the "Releasees") from any and all liability and/or claims, suits, damages, injury, disability, death, costs and expenses, whether arising during travel to or from the Event, whether arising before, during or after the Event and whether caused by the sole or joint negligence, gross negligence, or tortious act or omission of the Releasees or any third party (collectively the "Claims"). The Releasors hereby knowingly and voluntarily waive, to the fullest extent permitted by law, the benefits of any statute, law, rule, or common law which may limit the scope of this Release and Waiver.

Notwithstanding any provision herein to the contrary, this Release and Waiver does not release and is not intended to release any claims Releasors may have against any person and/or party other than the Releasees. Moreover, notwithstanding anything herein to the contrary, the willful misconduct of the Releasees is expressly excluded from the scope and application of this Release and Waiver.

The Releasors are aware of, and understand fully, the potential risks involved in connection with travel to and from the Event and that serious injury and death may occur, and each of them assume full, sole, and complete responsibility for, and risks of, death, personal or bodily injury, disability and/or property damage resulting from, in connection with, or in any way related to, Participant's participation in travel to and from the Event and the Event itself. The Releasors understand that the ASUNAA DCAAC has not certified or investigated the professional bus service providing the transportation to and from the Event and makes no statement or warrantee as to the safety of said transportation.

The Releasors represent and warrant to the Releasees, that Participant(s) has no medical condition (physical or mental) which would or could impact on the Releasees allowing Participant to travel to and from the Event and that the Participant(s) is/are physically able to travel to and from the Event.

Releasor also acknowledges that the Participant(s) agrees to follow the instructions of all chaperones, employees, agents and representatives of the ASUNAA DCAAC.

Furthermore, the Releasors acknowledge that the Releasors have received the opportunity (and been strongly encouraged) to review this Release and Waiver with an attorney, that the Releasors have carefully read and fully understand the contents of this Release and Waiver and that the Releasors have duly executed this Release and Waiver freely and voluntarily, intending and agreeing to be fully bound by the terms hereof.
